NOTICE OF VIOLATION - 75 Pa.C.S. §3369 Work Zone Speed Safety Cameras

You have been identified as the owner of a vehicle that exceeded the posted speed limit by at least 11 MPH in an active work zone. An automated speed enforcement system detected and recorded the violation at the place, date, and time shown on the Notice of Violation. You must respond by the Due Date on the Notice of Violation. You have two options:

Option 1: Pay the Civil Penalty

If you choose this option, detach the payment coupon on the reverse side of this page and enclose a check, money order, or credit card information for the amount due. Credit card payments may be made online at workzonecameras.penndot.gov or by phone at 1-800-390-7151. Make checks and money orders payable to:
Work Zone Speed Safety Cameras Program.

FAILURE TO PAY – If payment is not received in full by the Due Date on this Notice of Violation, you will receive a late fee up to \$75. Additionally, you could be referred to a collection agency.

NOTE: This is a civil penalty. No points will be assessed against your driver record for this Notice of Violation.

Option 2: Request a Hearing to Contest Liability

If you choose this option, the owner may contest liability by requesting a hearing by the Due Date of this Notice of Violation.

Defenses to liability are:

- The vehicle was reported to a police department as stolen prior to the time the violation occurred and was not recovered prior to that time.
- The person receiving the Notice of Violation was not the owner of the vehicle at the time of the offense.
- The device used to determine speed was not in compliance with 75 Pa.C.S. §3368 (relating to speed timing devices) with respect to testing for accuracy, certification or calibration.
- The person named in the Notice of Violation was not driving the motor vehicle at the time of violation.

The owner may request a hearing by either (1) submitting a request through the program website, or (2) submitting the Hearing Request Form on the reverse side of this page.

- The Hearing Request Form may be submitted online through the program website at workzonecameras.penndot.gov. Go to the **Violations** tab and click on **View Your Violation**. Log in by entering the Violation Number, License Plate Number, and PIN Number for the Notice of Violation. Click on the **Contest Your Violation** button and complete the form.
- The Hearing Request Form may be submitted by mail or in person at the Work Zone Speed Safety Camera Program Customer Service Center (CSC) located at 740 Arch Street, Philadelphia, PA 19106. The Service Center is open weekdays from 8:00 AM to 12:00 PM and 1:00 PM to 5:00 PM, and the last Saturday of each month from 8:30 AM to 12:00 PM (excluding holidays). Note: If you are requesting hearing at the walk-in location, the hearing will not occur at the time of the request. You will receive by mail a written confirmation of the date, time and location of your in-person hearing.

The owner may choose a written determination by a hearing officer based on the documents provided or an in-person hearing before a hearing officer.

- Hearings are offered virtually or in-person.
- If you request a virtual hearing, you will receive written confirmation by mail of the date and time of the scheduled hearing. A synchronous video conference link will also be provided with the written confirmation.
- If you request an in-person hearing, you will receive written confirmation by mail of the date, time and the location of the scheduled hearing. You may request a preferred hearing location. Hearing offices are located in Erie, Pittsburgh, Harrisburg, Philadelphia, and Scranton metropolitan areas.
- If you request a written determination without a hearing, the hearing officer will make a decision based on documents only. You will receive instructions by mail on how to submit your supporting documentation. Instructions for submitting supporting documentation are also available on the program website.

FAILURE OF THE OWNER TO REQUEST A HEARING BY THE DUE DATE WAIVES YOUR RIGHT TO A HEARING
